TO OBTAIN A KEY:

1. Your knowledge of range safety and your conduct must be approved by the Chief Range Officer, Assistant Range Officer or their Designee.
2. You must know how to secure the building(s) and their proper operation, including:
 - A. Lights
 - B. Heat/Ventilation
 - C. Air Compressor
 - D. Clean-up
 - E. Lock-up.
3. You must attend a minimum of two (2) general meetings per year.
4. You must attend a minimum of three (3) scheduled work details per year performing such functions as the following:
 - A. Range maintenance - grass cutting, cleaning, etc.
 - B. Target runners
 - C. Range Officer, Block Officer, or other Match Official
 - D. Stat Office
 - E. Kitchen
5. Pay the required fee (\$ 10.00) annually.
6. No Associate member, voted in after April 1, 1981, is entitled to a key.
7. Every key holder will receive a copy of these regulations with their key.
8. Failure to comply with all of these regulations will be cause for a key NOT to be issued.
9. It is your responsibility to get authorized initials where applicable to substantiate validation.
10. All club keys in your possession must be promptly surrendered if/when demanded.
