- DATES:** September 18-19, 2010 (Saturday & Sunday)
- LOCATION:** 8081 Greenbush Road, Akron New York, County of Erie.

- LODGING:** Lodging is available off site. RV's or campers may be parked on-site -- call for more information.
- MEALS:** Our kitchen will serve a light lunch on match day. Expect usual grill items (dogs, sausages), pop, water, coffee, etc.
- RULES:** NRA Pistol Rules will apply throughout.
- ELIGIBILITY:** Open to all competitors, however, membership in the **New York State Rifle and Pistol Association (NYSRPA)** is **REQUIRED** for New York State residents. Non-residents must be members of their own state association. NYSRPA membership applications will be available at the range. **ALL COMPETITORS MUST BRING PROOF OF NYSRPA OR STATE ASSN MEMBERSHIP TO THE MATCH!**
- ENTRIES:** **ALL SHOOTERS MUST PREREGISTER.** Use the registration form on page 5 of this program. The minimum amount that must accompany your entry is **\$25.00** registration fee in the form of a check or money order payable to **TEN-X SHOOTING CLUB, INC..** Be sure to indicate your correct classification and category, if any.

- ENTRIES CLOSE:** Individual entries must be received by September 8, 2009 to GUARANTY berthing. Post-dated entries and show-up entries will be permitted to range capacity of 30 shooters. A \$2.00 post-date entry fee may be assessed to late entries.
- ENTRY LIMITS:** Entries limited to range capacity of 30 persons per relay.
- SAFETY:** Shooters must provide and wear their own eye and ear protection. Regular eyeglasses are permitted.
- CONSOLIDATIONS:** Ten-X reserves the right to combine or delete relays due to lack of entries.

ENTRY FEES: Entry fees are as follows (must be paid in U.S. dollars):

Individual Matches:

- 1 Gun:.....\$30.00 (Matches 1-5)
- 2 Gun:.....\$40.00 (Matches 1-5,7-11)
- 3 Gun:.....\$50.00 (Matches 1-5,7-11,13-17)

- 3 Gun SCORE ONLY.....\$30.00 (Matches 1-17)

Above amounts include \$ 5.50 NRA REGISTRATION, \$ 6.00 NYSRPA REGISTRATION.

Teams.....\$ 12.00 per team (MATCHES 6,12, & 18)

TEAM ENTRIES: Four person teams to fire. Firing members must be chosen prior to the start of the .22 caliber National Match Course. Team matches are unfired and consist of each member's national match course score from each caliber. Teams compete for an open award only - there will be no teams within class and category. Team scores forwarded to NYSRPA for state ranking by classification and award.

CLASSES: A minimum of five (5) competitors are required to constitute a class and a minimum of five (5) competitors required for a separate category within a class.

The combining of classes and/or categories is within the discretion of the sponsor. Lower classes will be combined with higher classes to form a class per above rule, except that if fewer than 5 High Masters are present, High Masters will not be combined with any other classes and will compete for Open awards only. Consolidation rules will be posted on the bulletin board. The regular NRA classification system will be used, consisting of High Master, Master, Expert, Sharpshooter, and Marksman. Unclassified competitors and competitors without proof of classification will fire in the master class. NRA temporary score books will be accepted as proof of classification.

AWARDS: Awards will be given in cash, NRA points or equivalent trophy / Blackinton Medal as requested. Sponsor's awards are as follows: Open Awards: Match Winner in each Match. Open Match winners are not eligible for class and category awards. Class & category awards as follows: first place in class and category. A second-place in class and category will be awarded provided there are at least 11 competitors in class and category. A third place in class and category requires 21 competitors in class and category. See CLASSES, above for consolidation rules. Sponsor will provide the following special awards: separate award to high junior, high senior, and high woman in the match. Only one team award (match winner) will be offered, provided at least two teams are mustered.

The following awards will be provided by the New York State Rifle and Pistol Association: Open Champion &/or High Resident, First (1st) High Master; 1st Master; 1st Expert, 1st Sharpshooter; 1st Marksman; High Service/Police; High Senior (60+); High Grand Senior (70+); High Woman; High Junior; New York State Team Champions.

CHALLENGES: Challenges will be per NRA rules. A \$1.00 fee per challenge will be charged and returned if the challenge is upheld.

SCHEDULE: One (1) full relay per day. The relay begins at **0900** hours. Competitors should arrive no later than 30 minutes prior to the start of the match to sign in & set up.
