An Amendment to the
Ten X Shooting Club, Inc., Constitution.

Existing Clause:

ARTICLE III
MEMBERSHIP

1. Any citizen of the United States 18 years of age and over may become a Regular member of this organization on a vote of the Board of Directors, on unanimous approval of members present, and on payment of the usual initiation fee and dues.

Proposed Replacement Clause:

ARTICLE III
MEMBERSHIP

1. Any citizen of the United States 18 years of age and over may become a Regular member of this organization on the recommendation of the Board of Directors, and on approval of 2/3 of members present at a Regular Meeting, and on payment of the usual initiation fee and dues.

Per Article X of the constitution, this will be presented at the November 7, 2016 and December 5, 2016 meetings and voted on twice, once at each meeting. If you cannot attend these meetings you may submit a proxy vote for one, but not both of these meetings.
